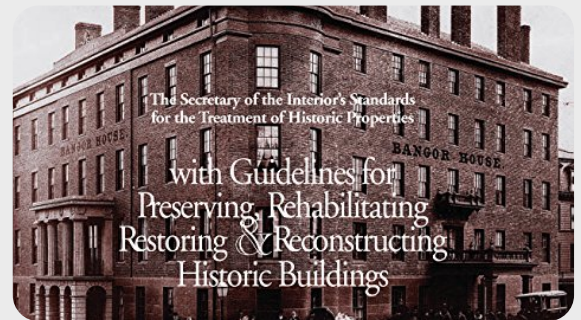


## **Historic Preservation 101**

This session equips you with a basic understanding of the structure, hierarchy, and terminology of historic preservation. A number of organizations and the basics of different types of designations that are frequently involved in historic preservation activities are also included.

## **Standards and Guidelines**

This session creates a deeper understanding of the relationship between federal standards and local design guidelines. This will provide an overview of the SOI Standards and the local guidelines and how to use and interpret the guidelines. .



## **Legally Defensible Commission**

Review the legal basis for how the Historic Preservation Commission makes its decisions and has its authority. Learn how to make decisions and motions that are legally defensible in court using the adopted Design Guidelines and Zoning code.

## **Design Review Basics**

Lays out the procedural steps for local design review and examines the various design standards by which commissioners evaluate applications.

Scope of review, roles of the public, potential actions and standards of review are also covered. A design review exercise is included in this session..



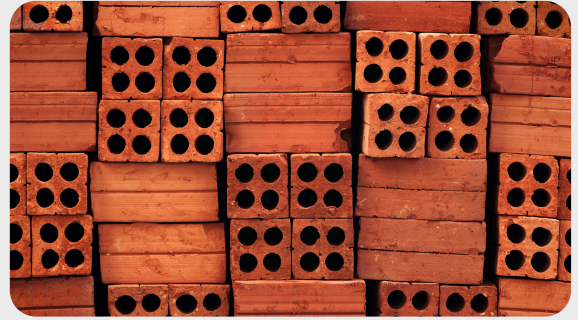


# TRAINING SESSIONS

## Substitute Materials

Focused on how to make decisions on replacement materials, this session shares an evaluation process that can help the Historic Preservation Commission determine when original materials should remain or if a substitute material is appropriate.



## Historic Building Styles

This session will go over the basic architectural styles that are in your community. Architectural elements that make up the style as well as historical background of each style will be highlighted.

## Building Relationships with Applicants

The Historic Preservation Commission is first tasked with upholding the design guidelines through their decisions, but they should also be able to provide guidance, advice, and suggestions to applicants to make the process more friendly and strengthen projects. Learn strategies to make the commission an important resource for applicants. .



## Four Strategies of Infill

How truly modern can you go and still be compatible? There is a wide spectrum of what differentiated but compatible means. This session will help you find your community's place on this spectrum. It is especially useful for commissions that have few architects/designers, do not have frequent infill applications or are struggling with infill review.

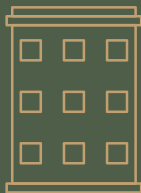
